Order

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Tarasankar Bandhyapadhyay B.Ed. Institution, P.O.: Kuchuighata, Dist-Birbhum, West Bengal – 731201, has submitted an application (Code No. APE00512) to the Eastern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course of one year duration with an annual intake of 100 (one hundred) students.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources laboratory etc. for running the programme and has appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to Tarasankar Bandhyapadhyay B.Ed. Institution, P.O.: Kuchuighata, Dist-Birbhum, West Bengal – 731201 for conducting B.Ed. Course of one year duration with an annual intake of 100 (one hundred) students under clause 7(10) of Regulation dated 13-1-2006 subject to fulfillment of the following:

- (i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.

- (ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government etc, wherever applicable.
5. The institution shall submit the Eastern Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules Regulations and Orders made or issued thereunder, the Eastern Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
7. The institution shall maintain & update the Web-site as per provisions of NCTE Regulations including inter-alia:
- Copy of the Application Form
  - Land and Building Particulars
  - Staff Profile
  - Recognition letter
  - Information in terms of having fulfilled the conditions mentioned above, as and when due.
